

## **Terms and conditions for RIBA Radio Lucky Prize Draw**

1. Our lucky prize draw is organised by The Royal Institute for British Architects (known simply as 'The RIBA') of 66 Portland Place, London W1B 1AD, registered with the Charity Commission for England and Wales under number 210566.

### **How to enter**

2. The lucky prize draw commences at 09:00 (GMT) Thursday, 18 November 2021. Entries received after the stated closing date of 12:00 (GMT) Friday, 26 November 2021, will not be accepted.

3. Our lucky prize draw is free to enter, and no purchase is necessary. The prizes are (1) 2 x The Specials concern tickets at Trinity College Dublin on 2 July 2022 including one-night stay for two guests at a hotel in Dublin; and (2) 2 week-night stay for two guests in a treehouse at Mallinson's Woodland Retreat on a weekday in 2022 (dates to be agreed depending on availability).

The RIBA will not accept responsibility for entries that are lost, mislaid, damaged, or delayed, regardless of cause, including, for example, as a result of any postal failure, equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind.

### **Eligibility**

7. The RIBA Radio Lucky Prize Draw is open to RIBA Members only. This includes Chartered Membership, Associate Membership, Affiliate Membership, Student Membership, Fellow Membership and Chartered Practice.

8. Entrants must be aged 18 or over at time of registration to enter the RIBA Radio Lucky Prize Draw.

9. Only one entry per person is permitted.

10. In entering, you confirm that you are eligible to do so and eligible to claim any prize you may win. The RIBA may require you to provide proof that you are eligible to enter the lucky prize draw.

11. The RIBA reserves all rights to disqualify you if your conduct is contrary to the spirit or intention of the lucky prize draw.

## **The Draw**

12. The winners of the lucky prize draw will be chosen by random draw performed by Marsha Ramroop following the competition closing on 26 November 2021.

13. The winner will be notified on Friday, 26 November 2021.

14. The winner will be notified by email or telephone (using details provided at entry) within 7 days of being chosen and must provide a postal address to claim their prize. If a winner does not respond to the RIBA within 14 days of being notified, then the winner's prize will be forfeited, and the RIBA will be entitled to select another winner in accordance with the process described above.

15. The prize is non-exchangeable, non-transferable and no cash alternative is offered. The RIBA reserves the right to replace the prize with an alternative prize of equal or higher value if circumstances beyond the RIBA's control makes it necessary to do so.

17. The decision of the RIBA regarding any aspect of the lucky prize draw is final and binding and no correspondence will be entered into about it.

19. The RIBA reserves the right to hold void, cancel, suspend, or amend the promotion where it becomes necessary to do so.

## **Limitation of liability**

Insofar as is permitted by law, the RIBA, its agents, or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize except where it is caused by the negligence of the RIBA, its agents or distributors or that of their employees. Your statutory rights are not affected.

22. By entering, you agree that any personal information provided by you with your entry may be held and used by the RIBA or its agents and suppliers to administer the prize draw.

## **Governing law**
