

Notice of Elections for the European Branch

Notice is given that the following elections for the European Chapter will take place as set out below:

Chapter Chair

Any current Chartered member on the electoral register in the area covered by the Chapter shall be eligible for election as Chair. Successful candidates will serve from the 1 May 2025 until quarter one 2028.

Hon. Treasurer

Any current Chartered member on the electoral register in the area covered by the Chapter shall be eligible for election as Hon. Treasurer. Successful candidates will serve from the 1 May 2025 until quarter one 2028.

Hon. Secretary

Any current Chartered member on the electoral register in the area covered by the Chapter shall be eligible for election as Hon. Secretary. Successful candidates will serve from the 1 May 2025 until quarter one 2028.

Student Rep

Any current student member on the electoral register in the area covered by the Chapter shall be eligible for election as Student Rep. Successful candidates will serve from the 1 May 2025 until quarter one 2028.

Chapter Committee (four members)

Any current member on the electoral register in the area covered by the Chapter shall be eligible for election to the Chapter Committee. Successful candidates will serve from the 1 May 2025 until quarter one 2028.

The qualifying date to participate in this election was Tuesday, 11 March 2025.

Nominations

Candidates can nominate themselves by submitting nomination papers using this <u>LINK</u> by the deadline published in this notice.

Nominations will open at 09.00 on Friday, 28 March 2025 and close at 16.00 on Friday, 4 April 2025. By that time, completed nominations must be received by the Returning Officer through the online nominations form.

We encourage you to submit your nomination form well before the deadline, as late or incomplete nominations cannot be accepted.

Timetable for Elections

In elections where there are more candidates than available positions, ballots will be held to the following timetable:

Voting opens - Friday, 11 April 2025. Voting closes - Thursday, 24 April 2025.

The RIBA Elections Officer will be the Returning Officer.

Online elections

The RIBA has a commitment to sustainability and using resources effectively and efficiently. In line with this, the entire election process will be conducted online. Nominations can only be made electronically - through the RIBA elections portal.

Please note that nominations by post are not possible in these elections.

Whether as a candidate or elector, participation in the elections will only be possible if a member has a registered email address with the RIBA.

- Members who wish to participate in the elections and have not yet registered an email address with the RIBA are therefore asked to do so no later than Friday, 4 April 2025.
- Members who have recently changed their email address are asked to update their information no later than Friday, 4 April 2025.
