Who can join

Chartered Members must meet one of the following criteria:

- RIBA recognised Parts 1, 2 and 3 (or equivalent)
- RIBA recognised Parts 1 and 2 with at least 2 years professional experience post Part 2
- Awarded a qualification in architecture which is covered by the Professional Qualifications Directive (2005/36/EC), have access to the profession of architect in the country in which the qualification was gained and have 2 years professional practical experience.
- Registered with the ARB via an ARB Mutual Recognition
 Agreement, and have a minimum of two years professional
 practical experience, where the applicant has not passed part 3.
- Group Eligibility-proof of full architect membership of one of the following 12 international institutes:


